



Namaste Trump: From Taj to Trade

A much hyped 36 hours visit of the U.S. President Donald Trump to India on February 24-25 concluded with some actions and many hopes and expressions. It was marred by lack of clarity on trade and economy front but, among other things, made subnational progress while underscoring the promise of expanding mutual cooperation on defence and energy fronts.
